

# **STOICON-X LICENCE AGREEMENT**

## **Introduction**

1. Modern Stoicism Ltd. is a non-profit that organises Stoicon and grants licences to permit independently organised Stoicon-x events.
2. The following are the objectives of Stoicon and Stoicon-x:
  - i. Share ancient Stoic life guidance on the basis that it has the potential to help people.
  - ii. Gather data on the effectiveness of ancient Stoic life guidance to determine to what extent it can benefit people.
3. When you agree to the terms outlined in this document (“the Agreement”), Modern Stoicism Ltd. will grant you a limited, revocable licence (“the Licence”) to organise a Stoicon-x event (“the Event”).

## **Limited Licence**

4. Modern Stoicism Ltd. has the right to revoke the Licence if you do not abide by any of the rules in this Agreement, or for any other reason.
5. The Licence will be valid for the purposes of organising only a single Stoicon-X event and only within a year of signing this Agreement. You must submit another signed Agreement and receive approval to hold any additional Stoicon-X event.

## **Conditions**

6. The Event must foster a supportive environment that allows people to share their ideas without excessive criticism or judgment.
7. The Event must be accessible to all and not discriminate on the basis of personal characteristics, including age, disability, ethnicity, religion, sex, sexual orientation or nationality.
8. The Event must not be used to profit the organiser/s. Money raised for the event, such as through ticket sales or sponsorship, must be spent on the event only. Any surplus funds must be donated to Modern Stoicism Ltd. or, by agreement, shared with the local organizing group.
9. The Event must acknowledge Modern Stoicism Ltd. as the owner of the Stoicon-X concept on your social media pages and at the event.

## **Waiver of Liability**

10. You will be responsible for all resources, equipment, staff, lodging, food or other materials necessary or required for the Event. Modern Stoicism Ltd. will not be responsible or liable for providing you with any resources, personnel or materials.
11. You agree to assume full responsibility for any and all injuries or damages you may sustain or cause others to sustain in connection with any Event, and to indemnify, defend and hold Modern Stoicism Ltd. and its staff and affiliates against any liability arising from such injuries and/or damages.

**Choice and Forum of Law**

12. The terms of this licence shall be governed by English Law, without regard to the conflict of laws principle. English courts will have exclusive jurisdiction for any dispute that has arisen, may arise out of, or in connection with, this Licence.
